What do the next 60 years look like?

We fundraise to create a better, more equal and inclusive world for people with learning disabilities.

We fundraise to overcome the inequality that people with learning disabilities in London face every day.

Many people with learning disabilities simply want to live an ordinary life. To have the same opportunities as other people who don't have a learning disability.

But there are barriers in place to getting the things that many people take for granted, such as having a home, good relationships, a social life and a job.

An ordinary life and ordinary expectations are not so ordinary. But they should be. We support people to have these important ordinary things.

Our focus over the next few years is on raising money to help people with mild and moderate learning disabilities who get little or no support from government-funding.

Government cuts, as well as the pandemic and the cost-ofliving crisis, have hit people, leaving them isolated and without support. Many have struggled with their mental and physical health, poverty and loneliness, and many at-risk people have fallen through the cracks.

To help these people we opened our first Community Hub in Westminster. This is a place where they can learn new skills, socialise and are part of their community.

Our ambition is to provide support to as many people with learning disabilities as possible across London and for no one to fall through the cracks. Our plan is to open a Hub in every part of the city where we work.

We want to make sure that no person with a learning disability experiences loneliness, exploitation, or a lack of opportunity, while we're here.

Questions you may have

Why should I write a will?

Why should I update my will and how do I do it?

Why should I leave a gift to charity?

What are the different types of gifts I can leave to a charity? A will makes it a bit easier for your loved ones at a difficult time as they are able to carry out your wishes.

Your circumstances might change over time, you may have children, get married or divorced and therefore change your wishes, so it's important to review your will regularly. To amend your will you will need to add a codicil – a document which your solicitor will help you draw up which is kept with your will.

Leaving a gift to charity means your values can live on, and you can continue to make a difference to the lives of others. Leaving a gift in your will is also a tax efficient way to support a charity.

There are three main ways to leave a gift to charity in your will:

Residuary – This is when you give a share of your estate or a percentage of what is left over once loved ones have been provided for.

Pecuniary – This is a set amount of money, you can choose any amount you want. It's worth reviewing now and again, as it may lose value over time due to inflation.

A specific item – you may wish to leave a specific item such as a piece of jewellery, an antique or even a property. This item should be named in your will.

What is an executor?

Can I include a trust fund to look after a vulnerable person? An executor is someone who is responsible for making sure the wishes you write in your will are carried out.

Yes, a trust can be created to look after a vulnerable person such as a relative who has learning disabilities.

Things to think about when making your will:

| Planning your will | The first step is to list your assets and think about the people and causes you would like to include. |

| Inheritance tax | Any gifts left to charities, including LDN London, are exempt from inheritance tax – so leaving a gift could reduce the tax to be paid on your estate. Inheritance tax is complex and often changing – to get advice and information you can find out more on the government website: <u>https://www.gov.uk/inheritance-tax</u> |
| Funeral plans | You may want to include funeral plans as part of your will. It can be reassuring for loved ones to know that they are carrying out your wishes. |
